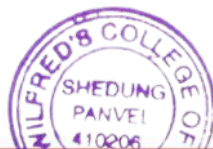

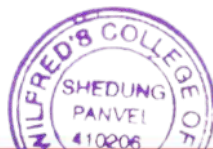

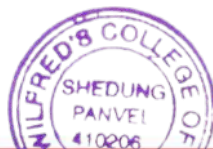

Minutes:

These programs will focus on improving students' Communication Skill Programme, teamwork abilities, time management, and overall personality development.
